2016 Health Clinic

This year's health clinic is scheduled for March 13, and most of the rest is the same....same location, same cardiologist, same ophthalmologist, same prices. There is one change. We have negotiated a deal with Paw Print Genetics for genetic testing this year. As you will see on the flier, participants will receive 25% off any test offered and if a participant chooses an entire panel of tests (see the website) for a breed, the panel will be discounted 40%. They do all the standard tests like EIC, HPNK, PRA etc. These tests can be done via blood samples or swabs. The company will provide the swabs, but we are requiring participants to do their own swabbing. We will have folks on hand if you would prefer to do the testing with a blood draw.

I have not yet made phone calls for help but will cheerfully take volunteers. We always need Chris Bell because I cannot do the rest of the clinic and also manage the money. We need a person who is polite, cheerful, and helpful to greet our clients and assist as needed in directing them to the right place and in filling out paper work...which is a lot less arduous than when all that bubbling was necessary. We need at least one person in addition to Dennis who is willing to put eye drops in dogs' eyes. We need a person who is the traffic coordinator outside the exam rooms, who isn't afraid to tell people to be quiet and keeps things moving in and out of exam rooms. That job often requires a great deal of patience by afternoon when we are running behind. Any additional help for people and paper shuffling is always appreciated...that way no one but Dennis, Chris Bell and I has to do the full day...you can work out shifts.

This is our single biggest income generator of the year and enables us to put on our specialty

Legislative News

The Senate Agriculture Committee will hear sponsor testimony on HB 187 and HB 60 on Tuesday, January 26, 2016, at 9 a.m. This is a first hearing for both bills.

HB 60 amends current companion animal cruelty law (ORC 959.131) to raise the penalty for deliberate cruelty.

HB 187 allows for waivers from civil liability for emergency medical personnel who treat dogs or cats.

Paw Print Genetics discounted testing

Any test submitted through our clinic to Paw Print Genetics will be discounted 25% and any full breed panel test will be discounted 40%. Please visit www.pawprintgenetics.com to see what tests are available for your breed. Testing can be done with cheek swabs provided at our clinic or with blood samples. Owners will be required to swab their own dogs or may have blood drawn for a \$10 fee. Ordering may be done day of clinic or in advance online. **Use discount code K9HEALTH now through March 14, 2016.
