Retail Pet Store Rule

USDA has changed the Animal Welfare Act regulations by revising its definition of retail pet store in order to keep pace with the modern marketplace and to ensure that animals sold via the Internet or other non-traditional methods receive humane care and treatment. USDA Animal Care has posted several materials on this webpage in an effort to provide all interested parties with pertinent information. We encourage you to please read through these materials in order to: 1) gain a better understanding of this regulation change; 2) learn the reasons that prompted the change; and 3) see if you need a USDA license or if you are exempt from licensing.

At USDA Animal Care, ensuring the welfare of the animals we regulate is at the heart of everything we do.

DOG OSTEOSARCOMA TRIAL

<u>Description of Study:</u> A new drug is being tested in dogs diagnosed with osteosarcoma (bone cancer) of the limb, mostly prevalent in larger breed dogs. Mouse and one preliminary dog study have shown evidence that after removal of the primary tumor, this drug may prevent metastatic tumor growth and provide a high quality of significantly prolonged life. To qualify for this study, dogs will have undergone limb amputation for removal of the primary cancer and have committed to undergo post-surgery standard of care consisting of five rounds of doxorubicin chemotherapy, the current recommended option to slow any recurrence of tumor growth. Dogs eligible to enter the study must have negative chest X-ray, that is, free of visible tumor metastases. At entry, dogs will be randomized to receive the drug or matching placebo. Since there is a very high rate for the development of visible cancer metastases in the lungs of osteosarcoma dogs during the first year despite negative chest X-rays at baseline, study dogs will continue to be screened for cancer metastases by chest X-ray every three months. Placebo dogs that develop metastases will be invited to receive the drug, as there is evidence showing that the drug may also be effective against advanced osteosarcoma in some dogs. Followup will be for one year in cancer-free dogs, with an invitation to continue drug therapy if so desired.

<u>Dogs that are Candidates:</u> Dogs of any breed and mixed breed dogs that have diagnosed osteosarcoma in a limb, have had amputation surgery to remove the primary tumor, commit to standard of care chemotherapy and have a clear lung X-ray with no visible lung metastases.

Study recruitment period: April 15, 2013 – April 15 2014

<u>Financial Support:</u> The drug will be provided free of charge to participant dog owners who will receive financial support of up to \$3,500 to cover all trial costs for visits and tests necessary to closely monitor any disease progression during the one-year study.

<u>Drug Safety:</u> The drug has only mild side effects consisting of occasional nausea, which is easily corrected, and in some cases, mild anemia during the initial drug dosing start-up period, also easily corrected with a short drug "holiday".

Canada Updates Regulations Regarding Importing Dogs

UPDATE (October 10):

The Canadian Food Inspection Agency (CFIA), which oversees animal imports into Canada, has clarified its regulations regarding the importation of "commercial" dogs, which includes dogs for shows and exhibitions as well as breeding dogs.

FOR DOGS UNDER EIGHT MONTHS OF AGE ENTERING CANADA FROM THE UNITED STATES—Dog owners and exhibitors with dogs under eight months of age are now required to present proof of their entry in a dog show, trial, or other competitive event when crossing the American-Canadian border. This is in addition to the already-existing requirements of:

- * A rabies certification (does not apply to animals three months old or younger)
- * a veterinary certificate of health whether or not they are accompanied by their owner
- * a microchip

Individuals without proof of entry in a show, trial, or other event are instead required to contact the CFIA Animal Health Area Office for the province they intend to enter at least 30 days before the dog is imported to apply for the permit and allow sufficient time for processing prior to entry into Canada.

FOR DOGS OVER EIGHT MONTHS OF AGE ENTERING CANADA FROM THE

<u>UNITED STATES</u> – Dog owners and exhibitors with dogs over eight months of age are required to present a valid rabies vaccination certificate issued by a licensed veterinarian. (Dogs imported for research purposes must meet more stringent requirements.)

Individuals interested in taking dogs into Canada for show, trial, or other event purposes are encouraged to refer to the CFIA's Automated Import Reference System (AIRS) at http://inspection.gc.ca/animals/terrestrial-animals/imports/airs/eng/1300127512994/1326599273148. The system provides detailed requirements personalized for each user.
