# **Commercial Dog Breeders Act**

Ohio Governor John Kasich signed Senate Bill 130, a law regulating certain dog breeding kennels and dog retailers, into law on December 11, 2012. The Commercial Dog Breeders Act becomes effective on **March 13, 2013**.

# **Licensing Requirements**

High volume dog breeders and dog retailers will be required to obtain a license from the Ohio Department of Agriculture. Applications for licensure must be received by the department no later than **June 13, 2013**.

# **Registration Requirements**

Animal rescues for dogs will be required to register their establishment with the Ohio Department of Agriculture.

The department will maintain a database of all persons registered to operate an animal rescue for dogs in Ohio.

# **High-Volume Dog Breeders**

- <u>High volume breeder</u> means any establishment that keeps, houses, and maintains adult breeding dogs that produce at least nine litters of puppies in any given calendar year and sells 60 or more adult dogs or puppies per calendar year.
- The law generally prohibits a person from operating as a high volume breeder in Ohio without a license issued by the Ohio Department of Agriculture (ODA).
- Anyone issued a license to operate as a high-volume dog breeder must adhere to standards of care developed and enforced by ODA and submit to regular (at least annual) inspections.
- Veterinary care must be provided through an established veterinary-client-patient relationship.
- Application fees for a high volume breeder license:
- o \$150 sells 9 to 15 litters
- o \$250 sells 16 to 25 litters
- o \$350 sells 26 to 35 litters
- o \$500 sells 36 to 45 litters
- \$750 sells 46 or more litters
- o Liability insurance or surety bond requirement:
- \$5,000 for keeping, housing and maintaining not more than 25 adult dogs.
- \$10,000 for keeping, housing and maintaining 26 to 50 adult dogs
- o \$50,000 for keeping, housing and maintaining more than 50 adult dogs

# **Dog Retailers**

- **<u>Dog retailer</u>** means a person who buys, sells, or offers to sell dogs at wholesale for resale to another or who sells or gives one or more dogs to a pet store annually.
- The law generally prohibits a person from acting as a dog retailer in Ohio without a dog retailer license issued by ODA.
- Anyone issued a license to operate as a dog retailer must adhere to requirements and procedures developed and enforced by ODA and submit to inspections as deemed necessary.

The application fee for a dog retailer license is \$500 regardless of the number of dogs kept or sold.

# **Animal Rescue for Dogs**

<u>Animal rescue for dogs</u> means any individual or organization <u>recognized by ODA</u> that keeps, houses, and maintains dogs and that is dedicated to the welfare, health, safety, and protection of dogs,

- o An animal rescue for dogs will not be recognized by ODA if the individual or organization operates for profit, sells dogs for a profit (see next bullet), breeds dogs, or purchases more than nine dogs in any given calendar year unless the dogs are purchased from a dog warden, a humane society, or another animal rescue for dogs.
- o An animal rescue for dogs may offer spayed or neutered dogs for adoption and charge reasonable adoption fees to cover the costs such as costs related to spaying or neutering dogs.
- o To be recognized as an animal rescue for dogs, an individual or organization must register the rescue with ODA.
- o <u>An animal rescue for dogs is not required to adhere to care and caging</u> standards.
- No registration fee shall be charged to an animal rescue for dogs.

# **Exemptions (From Registration and Licensing Requirements)**

- Medical kennels for dogs
- Research kennels for dogs
- Animal shelters for dogs that are operated by counties or municipal corporations (pounds)
- Veterinarians

Major crises have a way of bringing people together, and the horrific tornadoes that ravaged Oklahoma were no different. The EF-5 category tornado killed 24 people, injured many more, and destroyed more than 12,000 homes in its path. Once they got word of the damage, the American Kennel Club and AKC Companion Animal Recovery (AKC CAR) sprang into action. They offered assistance to each of the more than 20 member clubs in the affected areas, as well as contacted their more than one million subscribers letting them know what AKC was doing to help and how they could get involved with the relief effort by donating to AKC CAR. They also reached out to other organizations that were helping with relief efforts, specifically the Red Cross and Salvation Army, among others. With the help of club members and AKC staff in the area, they identified where the pet shelters were and got boots on the ground to help.

With only a 16 minute warning before the tornado hit, many people were separated from their beloved pets. AKC staff member Stacy Mason packed up her car and made her way to the Animal Resource Center where many pets were receiving care. She delivered a ton of supplies, including crates, bowls, and leashes, and stayed overnight helping out. AKC CAR then purchased two more rounds of supplies for the shelter, buying more crates and kennel runs for the dogs. Club members from the Mid-Del-Tinker Kennel Club, Oklahoma City Kennel Club, and the Lawton Dog Fanciers Association were on site helping as well, wearing AKC logo t-shirts.

AKC CAR donated 200 microchips and six scanners to a shelter being run by state personnel at the Moore Home Depot. In a major move, AKC CAR also donated \$10,000 to Oklahoma State University's Veterinary Medical Hospital to support veterinary work and boarding for animals injured by the tornado.

The Communications team worked feverishly to get the word out on all of AKC's social media channels, as well as networked with as many local sites and help resources as possible to push their message and assistance. They posted heartwarming pictures of owners reuniting with their pets, as well as of donations that AKC staff delivered.

For the benefit of those both in and outside of the affected area, the AKC has issued a list of suggestions for pet owners who have to leave their primary residence and seek temporary shelter after a natural disaster.
