Our year since Susan Moseley's diagnoses, and especially time after the hospital and rehab, was filled mostly with joy. She got out and about. She had plans for breeding and showing dogs. She had a new commercial van for a canine transport business. Her new puppy, Spin, a yellow lab from her line, had her smiling every day. She loved her dogs.

A week before Susan's death, when the doctor was telling her she was dying and he was giving her the immediate choice between going to the ER and hospital or setting up Home Hospice, she said: I want to live.

Her decline was rapid but she never lost her spunk or sense of fun. Susan died peacefully, at home, surrounded by her dogs and love.
