Purpose is to "establish licensing requirements and standards of care for certain dog breeding kennels, dog retailers, and animal rescues for dogs."

Ohio H.B. 108

"to specifically prohibit an owner, manager, or employee of a kennel of dogs from committing cruel treatment of a companion animal, to give a prosecutor who prosecutes an owner, manager, or employee of a kennel of dogs who commits cruel treatment of a companion animal discretion in prosecuting the owner, manager, or employee for the offense, and to remove certain language regarding the negligent treatment of companion animals."
