The Ohio Department of Agriculture, Division of Animal Health, is responsible for enforcing Ohio's Commercial Dog Breeding laws, specifically Chapter 956 of the Ohio Revised Code. Our office has received information stating you may be operating as a high volume dog breeder and/or broker in violation of ORC 956.04. Effective September 28, 2018 the definition of a high volume breeder has changed. Below are the new definitions:

A **high volume dog breeder** is defined as any establishment that keeps, houses, and maintains six or more breeding dogs and does at least one of the following:

- (1) In return for a fee or other consideration, sells five or more adult dogs or puppies in any calendar year to dog brokers or pet stores;
- (2) In return for a fee or other consideration, sells forty or more puppies in any calendar year to the public; or
- (3) Keeps, houses, and maintains, at any given time in a calendar year, more than forty puppies that are under four months of age, that have been bred on the premises of the establishment, and that have been primarily kept, housed, and maintained from birth on the premises of the establishment.

A **breeding dog** is defined as an unspayed adult female dog that is primarily used for producing offspring.

A **dog broker** is defined as a person who buys, sells, or offers to sell dogs at wholesale for resale to another, or who sells or gives one or more dogs to a pet store annually.

Ohio law prohibits an individual from acting as a high volume dog breeder or dog broker without being licensed by the Ohio Department of Agriculture. Please contact the Division of Animal Health, Office of Commercial Dog Breeders, **within fifteen (15) days** of the mailing of this letter in order to discuss your possible licensure requirements under the law (and whether or not you are acting as a HVDB and/or broker). You may contact the Office by calling (614)728-6220. Failure to contact our office will result in a citation of violation being issued in accordance with ORC 956.12.
